NWEC schedules board elections for February


orthwestern Electric has scheduled three board member elections for February. The districts are one, three and five and are highlighted on the map pictured below.



New office facility coming to Buffalo

orthwestern Electric's board of directors recently voted to build a new office building and expand the current warehouse facilities in Buffalo. The decision came after management explored the possibility of updating the current facility. The cost to remodel would have been extremely expensive and wouldn't correct all the problems with the old building.

Northwestern Electric acquired the town of Buffalo and the surrounding area in 1943 from Panhandle Public Service Company. In 1959, NWEC purchased the old creamery building at 102 West Turner and converted it into the district office headquarters.

The facility has served the members in the Buffalo area for over 55 years, but the years have taken their toll on the current building. The roof

leaks, the electrical system is not up to code, the building is not completely ADA compliant and there is not enough office space to accommodate the 11 employees stationed in Buffalo.

When you factor in the Cooperative's growth with the deteriorating conditions of the building, the need for a new facility is evident. Over the past 74 years, NWEC has grown from serving 82 consumers with 29 miles of energized lines to 11,892 meters with 4,966 miles of line. Buffalo has grown from using an average of 41,800 kWh to 885,569 kWh per month.

The board of directors felt the timing was right to build a new office. "The Cooperative is in good financial condition and interests rates are low," said CEO Tyson Littau. "We believe this is the best time to move forward

with this much needed project. The board carefully considered the impact this might have on retail rates and they determined the project will not be a factor in increasing costs to our members."

Northwestern Electric is excited and confident in its decision to invest in a new facility. "While other businesses close their local facilities, NWEC is making an investment in the Buffalo community. This helps position us for future opportunities and growth, but more importantly, it solidifies our commitment of providing reliable service to the Buffalo district," Littau says.

Construction is scheduled to begin in the near future. The new building will be located directly west of the existing building. Once the new office is completed, the old building will be torn down. NWEC has hired Joe D. Hall Construction to oversee the project.


