NWEC schedules board elections for February

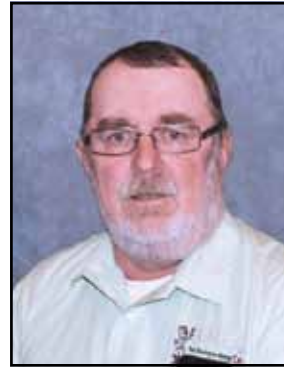
Northwestern Electric has scheduled three board member elections for February. The districts are two, four and six, and are highlighted on the map pictured below.

District 2, represented by Clair Craighead, will meet at NWEC's Medallion Room in Woodward on Tuesday, Feb. 9. The District 4 meeting is Thursday evening, Feb. 11, at the Sharon United Methodist Church. John Bruce, Jr. is the current director. Wayne Hall has set the District 6 meeting for Monday, Feb. 22, at the Quinlan Methodist Church.

According to Tyson Littau, Northwestern's CEO, all three directors plan to file for re-election. The portion of the Bylaws pertaining to director nominations and elections was published in the December 2015 Northwestern Electric News. 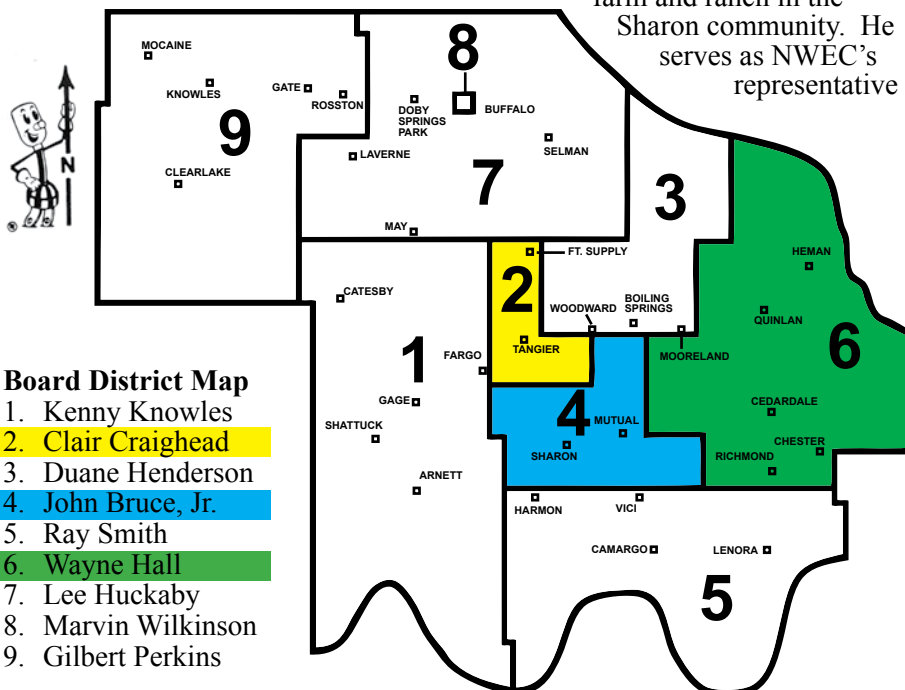

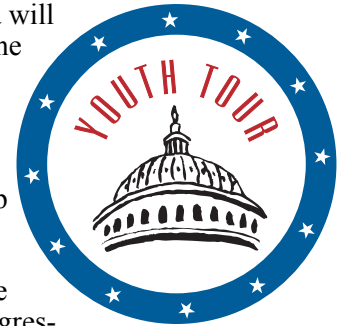


Students who wish to enter the contest must meet the following criteria:

Entry deadline is March 25, 2016.

Two students from this area will win all-expense-paid trips to the nation's capital, June 10-16, 2016, and two others will win \$500 scholarships and the opportunity to participate in the Touchstone Energy Leadership Summit.



The thrill packed days in Washington, D.C., will include lunch with the Oklahoma Congressional Delegation, tour of Mount Vernon, a boat trip on the Potomac River, and many other points of interest.

Northwestern Electric representatives will select the winners for the contest from students who take a written test over materials furnished by Northwestern Electric about rural electrification. (18694001)

Based on the test scores, the top four students will compete in a final judging which will be held at Northwestern Electric's headquarters in Woodward. A panel of judges will select two students for the trip based on subject knowledge, originality, appearance and personality.

Country cooking

Easy Enchilada Soup

- 3 cans chicken broth**
- 2 cans stewed tomatoes**
- 1 can whole kernel corn with juice**
- 2 cans black beans (drained & rinsed)**
- 2 cans (10 oz.) canned chicken**
- 2 envelopes enchilada sauce mix**



Combine all ingredients in a large pot and bring to a boil. Reduce heat and simmer for 20 minutes.

Serve over crushed tortilla chips and top with cheddar cheese, sour cream and chives.

High winds, tornadoes, earthquakes and ice

Where else but in Oklahoma can you experience all four in the same month?

Have you ever heard anyone say if you don't like the weather in Oklahoma just wait 24 hours and it will change? Northwest Oklahomans may believe that statement to be somewhat true after experiencing high winds, tornadoes and ice in less than a three-week span. And although they aren't weather related, some residents felt a couple of small earthquakes during the same time period.

Starting on Nov. 11, high winds knocked off the power at the Speer-more substation and took down some lines south of Woodward.

Less than a week later on Nov. 16, tornadoes ripped through the western portion of our service territory taking down over 120 poles. NWECC's crews along with five contract crews worked well past midnight on the 17th to restore power.

That same week, weather forecasters began predicting a major ice storm for our area. Round one of freezing rain and ice began Thanksgiving day causing outages mainly in the Vici and Camargo areas. Our crews were able to get the power back on by late the next evening.

Then came round two. Over the weekend, the linemen battled tree limbs and ice in Woodward County and the Vici area. More than 700

members were without power and the number doubled overnight. Although they were able to make some progress, the linemen knew the worst was yet to come.

Just as expected, outage numbers increased during the day on Monday as the ice began melting off the lines and tree limbs. By early afternoon, almost half of NWECC's system was without power.

With the help of crews from Tri-County Electric Cooperative and two contractors, most of the storm damage had been repaired and the power was back on by late Wednesday evening.

Two small magnitude earthquakes shook things up a little for residents living in the Mooreland area. Fortunately for us, the earthquakes on Nov. 25 and Nov. 29 didn't cause any damage to NWECC's system.
